Questions	Answers
Where does data show that Covid-19 spreads most at the moment while people are staying in? At work? On public transport? At Supermarket?	At the moment, the data is showing that the greatest spread is within households (ie one person has been infected from outside the house and then has spread it to other members of the household). We do not have available data on the highest risk locations for where outside the household people are contracting it. The data is showing a wide range of locations - the key point is that transmission can happen in any location if people are close together, not wearing face coverings when indoors or travel or not regularly washing hands with soap after coming into contact with contaminated surfaces.
I have noticed supermarkets are no longer restricting numbers, how are you checking on safe numbers in stores?	The council carries out regular inspections and audits of all essential retail including supermarkets to advise managers on best practice of COVID secure measures. The inspections include checks on queue management, social distancing, availability of sanitizer and wearing of face coverings.
How would you advise disinfecting the building if someone has Covid-19? What method and what chemicals should be used and where can they be purchased? Is there any follow up for those declining the vaccine?	If individuals choose to decline vaccination when called as part of their priority group, this will not preclude them from changing their mind and having the vaccine in future. However, we would encourage anyone who

	<p>would like the vaccine to take it up as soon as it is offered. At present, a process for following up those who decline has not been confirmed.</p>
<p>Which LDD conditions will be included in Priority Group 6 of the vaccination programme? I have spoken to a number of Carers who are caring for people with ASD and Asperger's and would like to know if they will be included in this priority group for the vaccine.</p>	<p>Priority Group 6 of the vaccination programme covers “adults aged 16 to 65 years in an at-risk group.” More detailed information about the conditions covered can be found in the Greenbook, chapter 14a.
